The Mid-Michigan Chapter CPCU Society will award two \$1,000 scholarships for the 2026 – 2027 academic year.

The scholarship application requirements are as follows:

- Cumulative grade point average of 3.0 or higher
- Major in insurance, risk management, actuarial science, business, information technology, or another field related to the insurance industry
 - Applicants whose major is not directly insurance related must have insurance industry employment or internship experience
- Junior or Senior class standing or pursuing master's degree for 2026 – 2027
- Unofficial transcript through Spring 2026
- Resume and completion of the application
- One letter of recommendation from a professor, advisor, or employer
- Photo suitable for business publication

Applicants awarded the scholarships will be invited to attend a CPCU Society chapter luncheon meeting in fall 2026.
